#### From the Executive Secretary

We being this new school year with 517.374 NFL members. This figure includes the 19,317 new members added last school year.

For the third year in a row we finished with a financial surplus, the exact amount will not be known until the auditors are finished with their examination of the books. I take great pride in this accomplishment, particularly in light of the double digit inflation we all have experienced these last few years. NFL has not had a dues increase for members or schools during the last six years, even though the prices we pay for supplies and services continue to climb.

During this last school year I traveled over 40,000 miles visiting schools, tournaments and speech conventions, promoting, to the best of my ability, the goals of the National Forensic League. I will continue to travel as the need requires.

This last year 63 district chairmen were elected to help administer NFL in the local districts. The National Council election was also held. Mr. James Hawker, who had served on the NFL Council for 24 years and Mr. Ed Brower who had served for 7 years did not seek re-election. Mrs. Phyllis Barton of Princeton High School, Ohio and Mr. Donus Roberts of Watertown High School, South Dakota were elected to replace these two fine men. We all owe much to all our past council members and I feel certain our new members will add their knowledge and understanding to the national council work.

I have enjoyed these last three years as your Executive Secretary. They have been challenging and rewarding years. I look forward to working with each of you this coming year. If we all continue to work together as we have these past three years, speech education will grow stronger and we will all be the better, because we certainly will have helped to train thousands of young men and women to become the leaders of tomorrow.

- 2. That extra-curricular activities are the most valuable part of a student's high school educa-
- 3. That the four day work week would enhance the quality of life in the United States.
- 4. Honesty is more important than friendship.
- 5. The life of an unborn fetus is more valuable than the mother.
- 6. Capitalism is superior to communism.
- 7. Capital punishment is morally wrong.

These are suggested topics for tournaments during the first semester. In January we will release the topic for NFL District Tournaments. In late April or early May the National Tournament topic will be released.

### Minutes of Executive **Council Meeting**

June 16, 1980 **Huntsville-Hilton** Huntsville. Alabama

Present: Carmendale Fernandes, President; James Copeland, Vice President; Edwin Brower; James Hawker; Frank Sferra; Brother Rene Sterner, FSC; Ronald Last; H. B. Mitchell and Dennis Winfield. Mr. Winfield did not vote on any of the motions.

Phillis Barton and Donus Roberts, newly elected members of the

Council were invited to attend the meeting.

Moved and seconded that the Council send to the chapters for ratification and the adoption of No. 2 on the election survey which was a direct election. Motion defeated. Noes: Fernandes, Sterner, Copeland, Hawker, Mitchell, Last and Brower. Ayes: Sferra.

Election procedure will remain the same.

Moved and seconded that Mr. Winfield reapportion the district quotas in such a way that the maximum entry per school is 16 and the minimum entry per school is 6 for district tournament apportionment purpose. Carried unanimously.

The number of entries required in each event to qualify that event for

the national tournament will remain as is.

10 teams in debate

12 entries in LD, OO, DI, HI, BE, CE

12 schools in congress to send two students to the national congress.

8 schools in congress to send one student to the national congress.

Moved and seconded that the National Forensic League assumes no responsibility for the payment of royalties or other fees connected in the performance of any material in any contest at its district or national tournaments. Carried unanimously.

Mr. Sam Gregory of Gregory Insurance, Fort Wayne, Indiana appeared before the Council to present a program of offering inexpensive term insurance to NFL students. Moved and seconded that Mr. Winfield go ahead with this program. Carried unanimously. It is up to Mr. Winfield how NFL is to set this up.

Mr. Rich Lindstrum of the University of San Francisco appeared before the Executive Council to give further information on the 1982 national tournament scheduled to be held at the University of San Francisco on June 20-25, 1982.

It was suggested that in addition to the district chairman having the responsibility of getting congress bills in to the national office by May 1, we should add that if the chairman wishes, this responsibility can be given to the student who is elected to attend the national congress.

It was decided to publish the topics for Lincoln-Douglas debate as

follows: Several topics will be suggested in the September *Rostrum*. In the January *Rostrum* the topic for the district tournaments will be published. In May the topic for the national tournament will be published.

The rule regarding no cross over in the two debate areas at district tournament and national tournament should be changed to add "the same year," so that if a student participates in Lincoln-Douglas debate one year, that does not keep him from participating in two-man cross examination debate the next school year.

Moved and seconded that the district debate rules regarding the drawing of byes be changed as follows:

- 1. In the first two rounds, if there is an uneven number of teams, the byes shall be given to a different school in each round. (no change from present).
- 2. In round 3 and other rounds until there are less than 4 teams left, byes shall be given to teams who have lost to undefeated teams.
- 3. No team may have more than one bye unless only 3 teams remain. At that point an undefeated team must get a bye.
- 4. If there are only 3 teams remaining, draw the bye from undefeated teams not having a bye. If only one undefeated team remains, it must get the bye.

Carried unanimously.

Moved and seconded that the following changes be made in the national debate rules regarding byes:

At the national tournament should there be 7 teams remaining in debate with one undefeated team or 5 teams remaining in debate with one undefeated team, the bye shall be automatically assigned in all cases to the undefeated team, even if they have already had a bye. Carried. All ayes except Mr. Sferra voted no.

The Council had a discussion regarding the use of dormitories at the 1981 and 1982 tournaments. It was suggested that the people in charge of the dormitories have a statement ready for any students staying at the dorms, stating that any damage done to the dorms will be the responsibility of that student.

Mr. Ronald Last presented a letter from Richard Spady. This was referred to the November meeting on unanimous motion.

Motion made and seconded that consideration of a move of the NFL offices from Ripon should not be given without recommendation of the Executive Secretary. Carried unanimously.

Council passed unanimous vote of thanks to Mr. James Hawker and Mr. Edwin Brower for the time, effort and devoted service they have given to NFL.

Motion made and seconded that the meeting be adjourned. Carried unanimously.

## Five New NFL Hall of Fame Members

**Margaret Meredith** 

Independence-Chrisman High School, Missouri. Triple Diamond coach. She was awarded the leading chapter award three times. She served as district chairman 6 years. She won the Tau Kappa Alpha Trophy and had national champion in poetry. She qualified students to 32 national tournament, and had second place debate team. She qualified 25 girls to national tournaments in girls extemp. 20 students have appeared in the national finals. She received the National Sweepstakes Award and the Coach of the Year Award.

#### **Esther Kalmbach**

Toledo Whitmer & St. Francis de Sales High Schools, Toledo, Ohio. Triple Diamond Coach. She was awarded leading chapter award and was largest chapter in Western Ohio 8 times. Her school was largest in enrollments in Western Ohio 4 times. The school won the National Tournament Sweepstakes Award 3rd place and she had national debate champions in 1971 and 1972. Attained 200 points toward Kappa Alpha Trophy at Whitmer and 38 at St. Francis. She won district sweepstakes 8 times and retired the traveling trophy. She qualified students to 13 national tournaments.

#### Helen Malseed

McKeesport High School, Pennsylvania. Triple Diamond coach. She was the first woman to be elected to the National Executive Council. She received district chairman gold award 4 times. She received the leading chapter award 2 times and district traveling trophy 12 times. The school won the sweepstakes plaque 4 times. She coached a Speaker of the House and qualified students to 15 national tournaments. The school accumulated 120 national rounds of participation and 29 national student congress trophy points. She qualified over 40 students to the national tournament.

#### Rev. John J. Miday, S. J.

Cleveland-St. Ignatius High School, Ohio. Triple Diamond coach. He served as district chairman for the Northern Ohio District 4 years. He had the largest chapter in Ohio 11 times. He retired the traveling trophy and won sweepstakes 4 times. His school accumulated 31 points toward the national congress trophy and 103 rounds for Tau Kappa Alpha Trophy. He coached President of the National Senate and Speaker of the House in the National Congress. He received the leading chapter award twice.

#### **Dennis Winfield**

September, 1980

Mr. Winfield is Executive Secretary of NFL. He was elected to the NFL National Council in 1974 and then elected President of NFL in

1976. He coached in Oklahoma and Iowa before becoming Executive Secretary of NFL. He served as District Chairman of NFL in both states. He had students qualified for every national tournament that he coached, a total of 15 years. He had one national champion and several students in the finals of the national tournament. Mr. Winfield is holder of the Distinguished Service Key and Plaque. He is the first person to be elected to the Hall of Fame by the present members of the NFL Hall of Fame.

### 1980 NFL TOURNAMENT **WINNERS**

At the 1980 National Speech. Debate Tournament and National Student Congress 459 schools were represented by 851 students. The fiftieth NFL National Tournament was held at Grissom HS, Huntsville, Alabama.

Our National NFL host was Mr. R. Stanley Erwin of Grissom HS.

#### **National Trophy**

The National Trophy named in the memory of Mr. Bruno R. Jacob, founder of the National Forensic League, was presented to North High School from Fargo. North Dakota.

The award is presented to the

school which has the largest number of accumulated rounds of National Participation. The scoring is based upon one point for each round of individual event participation and two points for each round of cross-examination debate. Forty three rounds of National Participation was added to the previous total of North HS for a total of 317 rounds of National Participation. The points this year were earned by Beth Sanner, Eddie Magarian, Nadine Fassner, Shelley Metcalf, Kevin McCloskey, and Anne Vining. They were coached by Ms. Wanda Manther.
